The Fraternal Order of Police - United States Park Police Labor Committee (USPPFOP) Election Committee is accepting nominations for candidates to run for the USPPFOP Executive Board. Nominations for the offices of Chairman, Vice-Chairman, Secretary-Treasurer, Secretary, Executive Chief Steward - NY, Executive Chief Steward - DC, and Executive Chief Steward - CA will be accepted by the USPPFOP Election Committee. The term of office for this election will run for two years starting on January 1, 2020.

### **How to nominate a candidate:**

The Election Committee will accept nominations from any member in good standing either for themselves or another member in good standing by U.S. Mail; email to [USPPFOELECTIONCOMM@USPPFOP.ORG](mailto:USPPFOELECTIONCOMM@USPPFOP.ORG); direct request to a committee member; telephone request to a committee member, and by other manner of communication to a committee member. Anyone nominating a candidate must provide the following information about themselves or the candidate they are nominating:

- Include short statement - I, (Your Name), a member in good standing with the USPPFOP nominate (myself or if nominating another member their name) to be a candidate for the office of (Specify Office) on the USPPFOP Executive Board.
- Name of the member making the nomination
- Specify the office for which you are making the nomination.
- Name of the member being nominated
- Home Mailing Address of the member being nominated (Not a work address)
- Private Email address of the member being nominated (NOT A NPS.GOV ADDRESS)
- Mobile Phone of the member being nominated (Preferred- so that you can receive election related texts)
- Home Phone of the member being nominated (If Available)
- If you nominating another member you must provide your name, telephone numbers, home mailing address (Not a Work Address) and a Private Email (NOT A NPS.GOV ADDRESS)
- If you are nominating another person it is requested that you make them aware of your intention to nominate them to an office.

The Nomination and Election Process is governed by the USPP By-Laws and by Law, Rule and Regulation. (Links to these documents and information are at USPPFOP.ORG) Members and particularly potential candidates are encouraged to review the documents to be familiar with the process. Candidates will be notified by email when they have been confirmed as candidates by the USPPFOP Election Committee no more than 7 days after nominations close on August 1, 2019. When candidates are notified that they have been officially nominated they must accept their nomination in writing (email or U. S. mail) to the Election Committee by a deadline specified in the notification.

Candidates should consider putting together campaign materials for distribution to the membership. The USPPFOP Election Committee will email them to the membership. The details of this will be provided to the nominees.

Voting will be by U.S. Mail (Mandated by the USPPFOP By-Laws), in accordance with applicable laws, rules, and regulations. The tentative schedule is to mail the Election Announcement and the Ballots on September 3, 2019. The vote will end on October 3, 2019. This schedule will allow full compliance with notification and voting period requirements. The voting by mail will be handled by a professional firm specializing in conducting Labor Organization Elections that fully comply with applicable laws, rules and, regulations.
